Evaluation Methods Used:

The MyCE was evaluated using Chrome v. 80.0.3987.149 on a Windows 10 desktop computer. Assistive technologies used in this evaluation included NVDA (screen reader) and the Windows screen magnification function as well as exclusive use of the keyboard to navigate and operate the site content and functionality.
